NETWORK SERVICES AGREEMENT

HUDSON VALLEY DOG SANCTUARY ("HVDogS") is a not-for-profit organization that provides high quality, professional 'pet care' services and products to dog owners of age and special needs. HVDogS further provides a 'sanctuary' or safe-haven for abandoned or neglected dogs, and fostering and placement of rescued dogs, together with pet care services, preferably with dog owners of age and or special needs. For the purposes of this agreement, the term "HVDogS" refers to our not-for-profit organization, its directors, trustees, volunteers, managers, agents/independent contractors and employees. The term "Network Services Provider" or "NSP" (in both singular and plural forms) refers to the pet services' and or product company who is providing services or products through HVDogS. The term "Member" (in both singular and plural forms) means any dog owner whose pet is under the care of HVDogS and its NSPs.

According to the terms set forth herein I, _____, agree to join the HVDogS' service network and direct HVDogS to offer my services and or products to the Members they support.

As an approved NSP for HVDogS, I understand that I will benefit directly from revenue derived from the services and products I provide through HVDogS, or that I provide directly to Members who are referred to me by HVDogS. I further acknowledge and agree to the following terms of participation, which terms I understand may be modified from time to time.

- That I am willing to submit to a background screening and reference check for myself and any of my employees who are involved in services I provide either directly or by referral through HVDogS
- That I have been in the pet care services or products business for at least one year.
- That I can make a six (6) month commitment to HVDogS.
- That I carry all of the required liability insurance and bonding and will furnish this information if asked.
- That I am in excellent standing in the local business community.
- That neither I nor my company have been, or are currently, in any litigation resulting from my or my company's gross negligence or willful misconduct in connection with the services or products I provide.
- That I am passionate about providing quality pet care services and products, and to enriching the quality of lives of dogs and their owners.
- That I will be flexible and available to provide services or products to HVDogS' Members on 24 to 48 hours notice, including weekends and holidays.
- That I can participate, from time to time, in HVDogS' community/fundraising activities.
- That I will promote HVDogS to my clients, family, friends, local organizations etc.
- That I have read HVDogS' organizational plan and fully understand their philosophy, organizational objectives and Member booking/billing process; further, that I agree with their pricing guideline for services I provide, and will endeavor to drive my costs lower in support of HVDogS and their Members.
- That I am prepared to donate services from time to time.
- That I already have, or am willing to setup, a PayPal account.

Release/Waiver

As an NSP for HVDogS, I fully understand and support the organizational philosophy of HVDogS, and hereby grant permission to HVDogS to act on my behalf to offer my services and products to the members they support.

I understand that HVDogS has a signed 'waiver and release' from its Members concerning potential harm that could occur to the pet I am caring for while in my care. I agree to release and hold harmless HVDogS from all liability, including its directors, trustees, volunteers, managers, agents/independent contractors and employees, should the Member's pet become lost, injured or otherwise harmed; likewise, I release and hold HVDogS harmless should a Member's home or my business suffer any damage as a result of the services I provide to Members.

I understand that HVDogS has been granted permission to act on the Member's behalf, and in the Member's pet's best interests, by obtaining veterinary care should I deem it necessary for the health and well-being of the Member's pet. Further, that HVDogS or the Member will reimburse me for the cost of any and all veterinary and other reasonably necessary services whose costs may be incurred or borne by me. Further, I understand that the Member has attested that their pets are up-to-date on all vaccinations and will provide proof of this if asked. Also, that the Member's pet does not suffer from any life threatening or contagious conditions that may be exacerbated by exposure to other pets I care for, or expose other animals to undue risk while in my care..

As an NSP for HVDogS, I agree to exercise all due and reasonable care to prevent injury, illness or death to a Member's pet and prevent harm to a Member's home in their absence. However, in the event of illness, injury or death to a Member's pet, or damage to a Member's home, except those caused by reckless or negligent acts on my part, HVDogS shall not be liable for such injury, illness or death of their pet, or any damage to their home.

Understanding the terms and risks as stated above, I freely and voluntarily enter into this contract, including the release and waiver, with HVDogS. This contract is a full and complete instrument. No other warranties expressed or implied are valid unless stipulated above. I have read this service contract, release and waiver and understand the contents of this form.
